OUR GRANTS COMMITTEE AWARDED A TOTAL OF \$98,878 TO TEACHERS/STUDENTS/STAFF FOR INNOVATIVE CURRICULUM TOOLS AND CONTINUING EDUCATION. \$57,380 WAS AWARDED TO ISD 832 IN SUPPORT OF THE DISTRICT'S NEW MENTAL WELLNESS INITIATIVE. \$5,100 WAS AWARDED TO PROJECTS WHICH INCREASE AWARENESS OF THE CRITICAL ISSUES OF DEPRESSION AND SUICIDE, AND OVERALL MENTAL WELLNESS.
